- 11. It shall be the binding /obligatory on the appointee to serve the bereaved family with the income to be derived from the said employment for which an under taking shall also be obtained from the appointee duly attested by $1^{\rm st}$ Class Magistrate

Any confirmed deviation from the agreement shall result in the forfeiture of the job for which the appointing authority to initiate action and the appointee in such case shall be left with no right to agitate the matter before any forum whatsoever, after decision taken by the appointing authority.
