In terms of J&K Compassionate Appointment rules, 1994 notified vide SRO- 43 dated 22/02/1994, sanction is hereby accorded to the temporary appointment of Smt. Rubeena Jan W/o Late Bilal Ahmad Dar R/o Qasba Baghat (Hazratbal), Tehsil and District Anantnag as Health Educator, in the Pay Band of Rs. 9300-34800 with the Grade Pay of Rs. 4200/- in the Directorate of Health Services Kashmir, in terms of Sub rule (2) of Rule (3) of SRO-43 of 1994.


The appointee shall report to the Director, Health Services, Kashmir within a period of 21 days from the date of issuance of this order and shall be allowed to join only after production of the following documents/certificates in original:-

1. Academic Qualification Certificate.
2. Age & Health Certificate.
3. Permanent Resident Certificate.
4. Certificate from the General Manager DIC concerned and Deputy Director Employment concerned to the effect that no loan under any self-employment schemes has been availed by the appointee.
5. Dependent certificate issued by the Competent Authority.
6. All other relevant documents as required under SRO-43 of 1994.

The appointment of Smt. Rubeena Jan W/o Late Bilal Ahmad Dar R/o Qasba Baghat (Hazratbal), Tehsil and District Anantnag shall be subject to the following conditions:-

- a) Appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about her character and antecedents is received from the Additional Director General of police, CID, J&K, to whom a reference shall be made by Head of the Department concerned, the





candidate shall have no right to claim her appointment as Health Educator and her appointment shall be deemed to have been cancelled *ab-initio*.
b) Verification of the qualification/date of birth certificate and reserved category certificate (if applicable) from the concerned issuing authorities. If on verification the certificates produced by the appointee are proved fake or forged, the appointment shall be cancelled *ab-initio*.

Salary of the appointee shall not be drawn and disbursed to her unless satisfactory report in respect of (a) and (b) above is received.

The appointee shall be on probation for a period of two years. After appointment shall be governed by the provisions of SRO 400 of 2009 dated 24/12/2009 issued by the Finance Department.
