**Subject: - Suspension of Mr. Ab. Rashid Reshi Health Educator
Medical Block Tangmarg Baramulla.**

Whereas, as reported by Block Medical Officer Tangmarg vide her letter No.BMOT/285 Dated:-18.07.2018, Mr. Ab. Rashid Reshi, Health Educator presently posted in Medical Block Tangmarg, District Baramulla is absconding from his official duties w.e.f 06.07.2018.

Whereas, the said report further reveals that the official has gone outside the state for undergoing interstate training without seeking proper permission from the competent authority and without getting any relieving order.

Whereas, the said Health Educator is borne on the establishment of Directorate of Health Services Kashmir but has gone to Interstate training outside the state without consent and approval of the Department in violation of J&K CCA Rules of 1956.

Whereas, the said official has time and again resorted to mischievous activities and the recent one being the scuffle which took place in the Mission Director, NHM J&K between Dr. Yashpal Sharma and Dr. Mohan Singh.

Whereas, while carrying out his mischevious activities, he has submitted representation to the Principal Secretary to Govt. H&ME Civil Sect. Sgr in which disciplinary action has been sought against one of the senior most officer Dr. Mohan Singh Ex-Mission Director NHM which is beyond his capacity/competence.

Whereas, his presence at the said occurrence of event is totally unjustified as he should have been present at his place of posting and has made his presence in the office of Mission Director NHM J&K without seeking permission from the competent authority.

Now, therefore, in view of the above, his conduct would be purely dealt as unauthorized absence and sheer indiscipline as he has not informed the department though he was bound to take proper permission before joining the said training programme.

Therefore, it is ordered that Mr. Ab. Rashid Reshi Health Educator Block Tangmarg District Baramulla is hereby placed under suspension in terms of Rule 31 of J&K CCA with immediate effect and is attached with office of Block Medical Tanghdar Kupwara.

Besides a committee comprising of following officers/officials is hereby constituted to look into the unauthorized absence and conduct of the said official and submit its report/recommendations in the office of undersigned within 07 days positively.
