Subject: - 1st Tentative Seniority list of Junior Assistants (5200-20200) +Grade Pay (2400) of Kashmir Division.

CIRCULAR

Whereas, the on the basis of records available in this office the final seniority list of 19 Jr. Assistants in whose favor services were regularized on the recommendations of Empowered Committee in terms of J&K Special Provision Act of 2010 of Kashmir Division in the pay band of Rs 5200-20200) +2400 was prepared and circulated in terms this office circular No. Est-5/NG-309/S.L/JA/3032-82 Dated:-30.08.2018.

Whereas, the officials Figuring from S.no 01 to 19 were promoted to the post of Sr.Assistants in terms of this office order No:-29/NG of 2021 dated:-14.01.2021 purely on the recommendations of Departmental Promotion Committee. However, THE Officials figuring in the said seniority at S.no .06, 08, 14 were not promoted owing to the fact that one Ghulam Rasool Lone stands suspended as he was trapped by VOK now ACB while accepting Illegal gratification, Mst Ravinder Kour was not promoted as FIR stands registered against her in the office of ACB with regard to illegal appointment made in the office of CMO Srinagar and Mst Roshan Ara, the services in her favour stands terminated by this Directorate on being willfully unauthorizedly absence from duties respectively.

Whereas, three junior Assistants in whose favour the services stands regularized by the Empowered committee under different orders under the provisions of J&K Civil Services(Special provisions) Act 2010 have approached this Directorate for incorporation of their names in the seniority list of Junior Assistants of Kashmir Division as all the officials have completed their period of probation. Besides, one Arshid Ahmad Dar of this Directorate has also completed his period of probation as Jr Asstt as he has been appointed on compassionate grounds by virtue of Govt Order No: 208-HME of 2018 dated:-23.03.2018 and stands adjusted in this Directorate against the available post of Jr Asstt in Divisional Cadre Kashmir.

Now, therefore, in light of above details, the 1st tentative seniority list of Junior Assistants (5200-20200 GP-2400) of Kashmir Division (Divisional cadre) is hereby framed and circulated amongst all the concerned respective controlling officers for information of each individual working under their administrative Control for inviting objections if any. The objections should reach to this office within 10 days from the date of issuance of seniority list with documentary evidence. After expiry of the stipulated time no claim shall be entertained. The seniority list is also available on official website www.kashmirhealth.org.
