After expiry of the stipulated period, no objection in this regard shall be entertained and **the seniority list shall be treated as final.**

The date(s) of birth and category status of the officials reflected in the seniority list shall not be taken as authentic and shall be subject to further verification with the service record/Matriculation Certificate issued in respect of these officials by the concerned authorities. The seniority list shall be without prejudice to the final outcome of Writ Petition(s), if any, pending before the Competent Court(s) of Law.


