Subject:-Selection list of the candidates under SRO -202 dated:-30.06.2015 for the post of Electrician (Health & Medical Education Deptt), District Cadre Srinagar, Pulwama, Kupwara, Kulgam, Baramulla Item No.700, 692,683,680,666 (07 of 2015, dated:-02.12.2015)

ORDER NO. 30 / NG of 2020 DATED 33 / 12 /2020

Whereas, the Administrative Department Health and Medical Education J&K, vide their office letter No. HD/NG/177/2018 Dated:-22.10.2018 while forwarding the selection list/recommendations of Electricians (Health Department) District Cadre Srinagar, Pulwama, Kupwara, Kulgam, Baramulla received through Secretary J&K Services Selection Board Jammu vide letter No's SSB/Secy/Sel/2018/8997-03 Dated: 31.07.2018, desired to issue formal appointment orders in favour of selected candidates for the post of Electricians against various District Cadre posts, subject to the conditions as laid down in the above referred communication of Administrative Department dated:-22.10.2018.

Whereas, after fulfillment of procedural formalities, formal appointment orders were passed / issued in favour of selected candidates in each District, whose candidature was formally recommended by the J&K SSB under different orders issued vide No:- 134/NG of 2019 dated:-02.02.2019 and No-135/NG of 2019 dated:-02.02.2019.

Whereas, among the selected candidates in whose favour formal appointment orders were issued one Mr Abdul Majeed Lone S/o Mohammad Abdullah R/o Wahipora Handwara Kupwara failed to join within stipulated period of time and accordingly the appointment of said candidate for the said post was cancelled (RBA Category) in terms of this Notice No:-DHSK/Est-I/NG/Elec/81-88 dated:-15.05.2019 which was also got published in print media in Tameel Irshad in its edition dated:-18.05.2018.

Whereas, one candidate namely Mushtaq Ahmad Wani S/O Mohammad Yousuf Wani R/O Khumenyal Kupwara who was figuring in the waiting list at S.No .01 under RBA category with the condition that his recommendation is withheld subject to production of valid within date RBA category certificate

Whereas the matter was referred to Adm. Department for issuance of necessary instructions/ orders with regard to operating waiting list in respect of One Mushtaq Ahmad Wani S/o Mohammad Yousuf Wani R/o Khuminal Kupwara (RBA) vide this office letter No:-Est-I/NG/167 dated:-17.06.2019.

Whereas Administrative Deptt in terms of letter No.HD/NG/177/2018-Part file dated:-11.02.2020 forwarded a copy of letter No:-SSB/Secy/Sel/213/2018/303-05 dated:-14.01.2020 of J&K SSB where-under the withheld recommendation of Mushtaq Ahmad Wani S/o Mohammad Yousuf Wani was released.

Whereas this Directorate after receiving communication of Adm Deptt dated:-11.02.2020 with regard to release of withheld recommendation in respect of Mushtaq Ahmad Wani took matter again with Adm Deptt vide letter No:-DHSK/Est-I/NG/908 dated:-07.09.2020 therein requested to convey necessary orders with regard to operating of waiting list in respect of Mushtaq Ahmad Wani in Distt Cadre Kupwara under RBA against the non-joining candidate.

Whereas Administrative Deptt finally in terms of letter No:-HD/NG/177/2018-PF dated:-29.10.2020 conveyed approval of the Administrative Deptt for operating waiting list in respect of District Cadre Kupwara under RBA Category in favour of the candidate namely Mr. Mushtaq Ahmad Wani S/O:- Mohammad Yousuf Wani R/O Khumenyal Kupwara against the non-joining candidate.

Now, therefore, in pursuance of the recommendations made by the J&K Services Selection Board, J&K Jammu/Srinagar and as per the approval conveyed by the Administrative Department, Health and Medical Education Department under the above referred communication Dated:-29.10.2020. Sanction is hereby accorded to the appointment in favour of Mr. Mushtaq Ahmad Wani S/O:- Mohammad Yousuf Wani R/O:-Khumenyal Kupwara for the post of "Electrician" in District cadre Kupwara on regular temporary basis in the pay band of Rs.5200-20200 with Grade Pay of Rs.1900(Pre-Revised). The appointment of the appointee shall be governed under the provisions of SRO-400 Dated:-24.12.2009 and the appointee shall report to the Office of Chief Medical Officer Kupwara for his postings in the said District.

Moreover his appointment shall be subject to the following terms and conditions as laid down under SRO-202 dated:30.06.2015 read with S.O 194 dated:17.06.2020.

- 01. A person appointed under these rules shall be initially on probation for a period of two (02) years.
- 02. The appointee shall have to necessarily work for a period of two (02) years on the post against which he has been appointed and such appointee shall not be eligible for transfer for what so ever reason during the temporary service of two (02) years provided that any person appointed against any available vacancy on the basis of being resident of backward area or an adjoining of actual control shall serve in such areas for a period of not less than seven years.
- 03. During the period of first two (02) years, the appointee shall be entitled to minimum of scale of pay only applicable to the post against which he is appointed.
- 04. The appointee shall after completion of two (02) years period on probation be entitled to fixation of pay in the time scale of pay applicable to the post against which he is appointed.
- 05. He shall be entitled to Annual increments, dearness allowances, HRA and CCA after successful completion of his two (02) years services on consolidated salary.
- 06. He shall be entitled to the benefits under the Medical attendance rules, and leave rules from the date of his first appointment its self.

In addition, the appointment shall be subject to following terms and conditions:-

- a. The arrangements, if any, made against the said post will be simultaneously withdrawn and appointee adjusted.
- b. The Appointment in District/ Divisional cadre is non-transferable from one district/ division cadre to another district/ divisional cadre.
- c. The appointee shall be on probation for a period of two (02) years.
- d. The salary of the appointee shall not be drawn and disbursed to him/her till genuineness of his character & antecedents and received from CID and other agencies.
- e. If on verification, character and antecedents of the appointees are found adverse or the certificates produced by the appointees are proved fake or forged, his appointment shall be deemed to have been cancelled ab initio without any further notice.
- f. The order issued is without prejudice to the outcome of any petition pending before any competent court of law.
- g. The Chief Medical Officer Kupwara shall not draw his salary unless and until his requisite certificates got verified from the concerned quarters.

h. Verification of the recognition status/genuineness of qualification/category certificates/permanent resident certificate / domicile resident of concerned district for a period not less than 15 years except schedule caste category shall be made confidentially by the intending department from the concerned universities/institutions/ Departments and in case any certificate/ document during the course of verification turns out to be fake/ fictitious, the department may kindly be kept posted with such outcome so the criminal proceeding against such candidates are initiated.
