The appointment shall be subject to the following terms & conditions.

- 1. The arrangement, if any, made against the said post shall be simultaneously withdrawn and appointee adjusted.
- 2. The appointment in District/ Divisional cadre is non-transferable from one District/ Divisional cadre to another District/ Divisional cadre.
- 3. The appointee shall be on probation for a period of (05) five years.
- 4. The salary of the appointee shall not be drawn and disbursed to him/her till genuineness of his/her character and antecedents are received from CID and other agencies.
