MUHARRUM-2022 MEDICAL AID ARRANGEMENTS:

After threadbare discussion on the subject matter, the following decisions were unanimously taken:-

01. All the Chief Medical Officers will make all the necessary Medical Aid Arrangements for Muharram 2022, in their respective District, as per the past practice and keeping in view COVID-19 related SOP's in mind also.
02. They will ensure deployment of adequate staff for Medical Aid Arrangements, so that things move smoothly.
03. They will ensure adequate ambulatory services equipped with all equipment, as per past practice required for any emergency.
04. Chief Medical Officer Budgam will write to CMO Baramulla regarding provision of two ambulances from Block Tangmarg for Block Medical Officer Magam.
05. CMOs will ensure timely collection of Moharram supplies from Controller of Stores (Health) Barzulla. Besides, will convey non-availability if any.
06. Section Officer (Budget) of Directorate of Health Services Kashmir will ensure that the budget is provided as per the past practice; however the purchases if required shall be made after fulfilling all the codel formalities by the CMOs.
07. It has been desired by the chair that the Chief Medical Officers shall involve the NGO's in providing the Medical Aid during the Moharram, for which they will be given a certificate from the Department.

08. Keeping in view the Amarnath Yatra in District Anantnag and Ganderbal the chair further desired that the Chief Medical Officer, Anantnag and Ganderbal shall not deploy staff/ ambulatory Services to District Srinagar, Director Indian System of Medicine will be requested to provide the staff during the moharrum for Medical Aid arrangements to compensate the same.
