The date(s) of birth of the officials reflected in the seniority list shall not be taken as authentic for calculation of age/superannuation or any other purpose unless its verification/ authentication in accordance with Matriculation Certificate issued by State of Board of School Education J&K Srinagar. The seniority list shall be without prejudice to the final outcome of Writ Petition(s), if any, pending before the Competent Court(s) of Law.
