The seniority list shall be without prejudice to the final outcome of Writ Petition(s), if any, pending before the Competent Court(s) of Law.

The concerned CMO's/Controlling Officers shall ensure that no Senior Staff Nurse is left out who has been appointed by the competent authority through proper mechanism and in case any such employee is left out, the concerned CMO's/Controlling Officers shall furnish his/her complete biodata along with documentary evidence in order to include him/her at appropriate place/serial.


