Whereas, concerned employee has stated in his application that he has been placed in the seniority list of Supervisor Dental Technicians of Kashmir Division at S.No:27, whileas he is working as Sr. Dental Technician and requested for incorporation his name in the seniority list of Sr. Dental Technicians of Kashmir Division at appropriate place.

Whereas, final seniority list of Head, Supervisor & Senior Dental Technicians of Kashmir Division has been issued under this office No: DHSK/Est-4/NG-149/S.List/D.T/2019/3349-78 dated: 23-07-2019 whereunder his seniority stands fixed in the final seniority list of Supervisor Dental Technician at S.No:27 due to inadvertent error.

Whereas, the case of the incumbent was examined in this Directorate & it has been observed that the said official is holding the post of Sr. Dental Technician substantively in the Department w.e.from 22-05-2009 & his seniority was required to be fixed in the respective cadre at appropriate place.
