Subject:- Tentative Seniority list of Junior Theatre Technician

NOTIFICATION

Whereas feeding category for the promotion to the post of <u>Senior Theatre</u> <u>Technician</u> (Division Cadre) is/are <u>Junior Theatre Technician</u> posts (District Cadre).

Whereas Rule 19 Jammu and Kashmir Civil Services Decentralization and Recruitment Rules, 2010 provides that While making promotions from the District Cadre posts to the Divisional Cadre posts, the competent authority shall allocate to each District such number of posts as the ratio and proportion of the Cadre strength of each District bears to the total Cadre strength of the Division concerned, **as far as practicable** and make promotions accordingly.

Whereas maintaining District Seniority of each category for the purpose of promotion to the post of <u>Senior Theatre Technician</u> (Division Cadre) and then allocating share as per Rule 19 is **not practicable** due to following reasons:

1. Feeding Category employees mentioned hereinabove recruited or appointed after 2007 in newly created District become senior to their super seniors appointed or recruited during 1980s and 1990s in old Districts thereby creates hardship for those who have served the department from last more than two to three decades.

 Feeding Category employees who have earlier been recruited in Division Cadre but for SO 334 of 2022 dated 13.07.2022 are now reflected in respective Districts in which they have been initially posted creates another anomaly where to fix their seniority as new recruitment rules provide every junior category as District Cadre.

3. Feeding Category employees who have earlier been recruited in old districts but due to their initial place of posting now falling under the newly created District creates another anomaly as their seniority should be maintained in Old District in which they have been recruited but because of their initial place of posting are reflected in the newly created District.

4. Feeding Category employees who have earlier been recruited in a particular District or in Division Cadre but the in the interest of Administration have been transferred to one or more other districts and are serving there from last more than one decade creates one more anamoly.

Whereas Section 6 of the Original Jammu and Kashmir Civil Services Decentralization and Recruitment Act, 2010, inter alia provided that a person shall be eligible to the appointment to a district cadre post only if he:-

- I. is a **permanent resident** of the **State**;
- II. is a resident of the concerned district.

Whereas now the amended section 6 of the Jammu and Kashmir Civil Services Decentralization and Recruitment Act, 2010, inter alia provides that a person shall be eligible to the appointment to a district cadre post only if he:

is a [domicile of Union Territory of Jammu & Kashmir].

Whereas conjunctive reading of the original section 06 and the now amended section 6 of the Jammu and Kashmir Civil Services Decentralization and Recruitment Act, 2010 clearly deduces that any domicile in the Union Territory of Jammu & Kashmir irrespective of this

residence in a particular district can apply anywhere in any of the districts of the Union Territory of Jammu & Kashmir.

Whereas seniority of the appointees to a service have to be determined according to Rule 24 of the Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956.

Rule 24.seniority:- (1). The seniority of a person who is subject to these rules has reference to the service, class, category or grade with reference to which the question has arisen. Such seniority shall be determined by the date of his first appointment to such service, class, category or grade as the case may be.

Interpretation.-The words "date of first appointment" occurring in the above rule will mean the date of first substantive appointment.

Provided that the inter-se seniority in the case of those recruited direct except those who do not join their duties when vacancies are offered to them according to the positions attained by and assigned to them in order of merit at the time of competitive examination.

Whereas in terms of the Jammu and Kashmir Health and Family Welfare (Subordinate) Services Recruitment Rules, 2022 provided in S.O. 334 dated 13th of July 2022, promotion to the post of **Senior Theatre Technician** (Division Cadre) has to be made from feeding category posts of Junior Theatre Technician (District Cadre) which has necessitated drawing up of a combined seniority list of each category due to the reasons mentioned hereinabove and in light of Section 6 of the Jammu and Kashmir Civil Services Decentralization and Recruitment Act, 2010 in order to enable filling up of the available vacant posts of <u>Senior</u> <u>Theatre Technician</u> from eligible feeding categories of <u>Junior Theatre Technician</u> posts under S.O 334 dated 13th of July 2022.

Whereas, the date of birth/appointment/promotion reflected in the seniority list shall be subject to its authentication verification from the service book/DOB certificate/appointment order of the concerned official(s) by the concerned DDO as envisaged under rules.

Accordingly, tentative seniority list is hereby notified for inviting objections from any official aggrieved with his/her position in the seniority for representation to this Directorate within a period of Seven (07) days from the issuance of this Notification.
